c) No further planning matters raised. 048(19) Neighbourhood Development Plan - Cllr N Hayward gave an update on the progression of the Plan. 049(19) Highways and Parish Steward - Cllr D Spencer advised that he had spoken to the Parish Steward regarding the re-painting of the white lines on the pedestrian 'path' on Chestnut Road – he agreed to speak to the Highways Engineer about it on our behalf. 050(19) Rights of Way - Cllr N Hayward put forward an idea from Cllr R Gaunt to install permanent maps in the village showing the Rights of Way – it was agreed in principle. 051(19) Flood/Emergency Planning - no update received. 052(19) Arts Development Project - Cllr C Mansfield advised that she was frustrated by the lack of response from various village groups. It was agreed to have an informal meeting in August and to organise a village-wide meeting in September/October. The Clerk was asked to put an article in the Parish News with details of the Project in the hope of engaging some volunteers. 053(19) Village Hall - Cllr J Campbell gave an update on matters at the Village Hall. 054(19) Primary School - no update received. 055(19) Wiltshire Council - Cllr H Greenman gave an update on the change in Leadership at the Council and gave details of the Rural Parish Forum and Chippenham Area Board Meeting to be held on 17 July in the Sutton Benger Village Hall. 056(19) Clerk's Report - The Clerk's report was received. It was resolved to approve an increase in the Clerk's Annual Leave entitlement following 5 years b) continuous service to 50.3 hours per year. It was resolved to approve an incremental increase to SCP 13 (new NJC pay scale from 1 April 2019) for the Clerk with effect from the 1 May 2019. It was agreed to appoint Cllr C Mansfield to act as Line Manager for the Clerk.
